CONSULTATION STATEMENT

INFRASTRUCTURE DELIVERY SUPPLEMENTARY PLANNING DOCUMENT

Prepared under Regulation 12(a)(i-iii) of The Town and Country Planning (Local Planning)(England) Regulations

1. Background

This consultation statement sets out how the Borough Council engaged with local authority partners prior to the preparation and formal consultation of the draft SPD. This statement also sets out how the Council will comply with the Statement of Community Involvement (SCI).

This Statement has been prepared in accordance with Regulation 12 – Supplementary Planning Documents – Public Participation, of the Town and Country Planning (Local Planning) (England) Regulations 2012.

2. Early Stakeholder Consultation on the preparation of the Draft Supplementary Planning Document

The Borough Council contacted the three statutory consultees comprising Natural England, Environment Agency and English Heritage on an SEA screening assessment for a 28 day period from 7th **December 2012 to 18**th **January 2013.**

The three statutory consultees were also requested to advise whether Appropriate Assessment under the Habitats Directive (92/43/EEC) and The Conservation of Habitats and Species Regulations 2010 was also required.

2 responses were received with respect to the SEA screening report. Comments on the SEA screening assessment have been included within the SEA determination which accompanies the draft SPD.
