**Designation of Local Heritage Assets Supplementary Planning Document (SPD)** 

# **Strategic Environmental Assessment**

Determination under Article 9 of the SEA Regulations 2004

#### Introduction

1.1. This statement sets out the Council's screening assessment under Regulation 9 (1) of the Environmental Assessment of Plans and Programmes Regulations 2004 on whether or not a Strategic Environmental Assessment is required for the Designation of Local Heritage Assets Supplementary Planning Document (SPD)

## **Strategic Environmental Assessment**

- 1.2. Under the requirements of the European Union Directive 2001/42/EC (Strategic Environmental Assessment (SEA) Directive)) and Environmental Assessment of Plans and Programmes Regulations (2004) specific types of plans that set the framework for the future development consent of projects must be subject to an environmental assessment.
- 1.3. There are exceptions to this requirement for plans that determine the use of a small area at a local level and for minor modifications if it has been determined that the plan is unlikely to have significant environmental effects.
- 1.4. In accordance with the provisions of the SEA Directive and the Environmental Assessment of Plans and Programmes Regulations (2004) (Regulation 9 (1)), the Council must determine if a plan requires an environmental assessment.

## **Sustainability Appraisal**

- 1.5. Under separate legislation (the Planning and Compulsory Purchase Act 2004 and associated Regulations), the Council is required to carry out a Sustainability Appraisal (SA) for all Development Plan Documents. This considers the social and economic impacts of a plan as well as the environmental impacts.
- 1.6. In accordance with current Regulations (Town & Country Planning (Local Development)(England)(Amendment) Regulations 2009) SA is no longer required to be carried out for SPD. However, despite this, it is still necessary to determine whether there is the need for an SEA.

#### **Habitats Regulations Assessment**

- 1.7. Habitats Regulations Assessment is required to determine whether a plan or project would have significant adverse affects upon the integrity of internationally designated sites of nature conservation importance, or Natura 2000 sites. The need for HRA is set out within the EC Habitats Directive 92/43/EEC and transposed into UK Law by Regulation 102 of the Conservation of Habitats and Species Regulations 2010.
- 1.8. The Directive states that any plan or project not connected or necessary for a sites management, but likely to have significant effects thereon shall be subject to appropriate assessment. As the Designation of Local Heritage Assets SPD will not set the framework for future plans or projects there is no pathway (either direct or indirect) for significant effects to arise. As such, it is considered that Appropriate Assessment of the Local Heritage Assets SPD is not required. Moreover, it is for individual planning applications or plans that set the framework for those applications to undergo Habitats Regulations Assessment.

### **The SEA Screening Process**

- 1.9. The process for determining whether or not an SEA is required is called screening. In order to screen, it is necessary to determine if a plan will have significant environmental effects using the criteria set out in Annex II of the Directive and Schedule I of the Regulations. A determination cannot be made until the three statutory consultation bodies have been consulted: The Environment Agency, Natural England and English Heritage.
- 1.10. Within 28 days of making its determination, the authority must publish a statement setting out its decision. If it determines that an SEA is not required, the statement must include the reasons for this.

## Background to the proposed SPD

- 1.11 The Surrey Heath Local Plan contains policies for the protection of locally listed buildings and structures. Policy HE10 states that the Borough Council will maintain a list of structures which it considers to be of local architectural or historic significance. Policy HE10 states that this list will be reviewed periodically.
- 1.12 Proposed policy DM17 of the Core Strategy and Development Management Policies DPD (as submitted) will replace Policy HE10 upon adoption. However policy DM17 states that from time to time the Borough Council will review the heritage assets included on local lists.
- 1.13 The purpose of the Designation of Local Heritage Assets SPD is to update and adopt the methodology and criteria for the identification of buildings, structures and sites of local historic importance. Table 1-1 sets out further SPD details.

## **SEA Screening Determination**

1.14 Before making a determination under Regulation 9 the three consultation bodies were consulted between 18<sup>th</sup> May 2012 and 15<sup>th</sup> June 2012. The responses received are set out in Table 1-1.

- 1.14 This screening report sets out the Council's determination under Regulation 9 (1) of the Environmental Assessment of Plans and Programmes Regulations 2004 on whether or not an SEA is required for the Designation of Local Heritage Assets SPD.
- 1.15 Appendix 1 sets out the process for determining if the SPD will have significant environmental effects using the criteria set out in Annex II of the Directive and Schedule I of the Regulations.
- 1.16 On the basis of the screening process it is the Council's opinion that the Designation of Local Heritage Assets SPD does not require an SEA under the SEA Directive and Environmental Assessment of Plans and Programmes Regulations (2004). This is because there will be no significant environmental effects arising from its implementation, it is for guidance purposes only and it does not set the framework for future project consents.
- 1.17 This determination was made on 1<sup>st</sup> February 2012.
