COMMUNITY INFRASTRUCTURE LEVY ADOPTION**

In accordance with the Community Infrastructure Levy Regulations 2010 (as amended), notice is hereby given that Surrey Heath Borough Council adopt the Surrey Heath Community Infrastructure Levy Charging Schedule to take effect on 1st December .

The Community Infrastructure Levy is a new charge that local authorities will be able to collect on new developments in their area. It is based on a formula relating to the type and size of development and is collected when planning permissions for new developments are implemented. The funds gathered will be spent on infrastructure within Surrey Heath. The Community Infrastructure Levy Charging Schedule document is accompanied by other supporting documents including a CIL Assessment and an Infrastructure Delivery Plan.

Mr Philip Staddon BSc, DIP, MBA, MRTPI an independent Examiner appointed by the Secretary of State for Communities and Local Government considered the Community Infrastructure Levy Charging Schedule and accompanying documents at an Examination in Public held on 19th February 2013. The Examiner's Report, with its recommendations was received by the Council on 25th March 2014 and is published on the Council's website. The adopted Community Infrastructure Levy Charging Schedule contains the Inspector's recommendations that are binding on the Council.
