On the 24th of June 2024, Surrey Heath Borough Council resolved to endorse the Pre-Submission Local Plan and delegated minor changes and formal submission. The revised NPPF (discussed in more detail in Q17) represents a major shift in the implications of how the Pre-Submission Local Plan would work even if adopted in its current format. More pertinently the changes required to make the Plan sound would also now represent a significant increase in housing requirement and additional allocations, far beyond what was endorsed and delegated by the Council in the June meeting.

In addition, submission of the Pre-Submission Local Plan to the Secretary of State for Examination would be in direct conflict with the accompanying Written Ministerial Statement which was published alongside the NPPF, and is a material consideration pertinent to the evolution of the New Local Plan. Again, highlighting the increasing requirement for new housing, noting that Surrey Heath is likely to see a 106% increase in its annual housing requirement (under the proposed reforms), from 320 to 658 dwellings per annum.

Whilst it is accepted that the revised NPPF is out for consultation (closing 24th Sep), given the timing of the two consultations there will be insufficient time to fully review and adequately assess the Pre-Submission responses and make any required amendments for Council to re-consider or for submission of the Pre-Submission Local Plan to the Secretary of State before the revised NPPF is fully endorsed.

On 30 July, the new Government introduced its Planning Reform agenda. This included a Written Ministerial Statement, Draft NPPF and draft revised standard methodology for housing delivery.

These documents are also subject to consultation until the 24th September, however, the Labour party manifesto and the Written Ministerial Statement signal the new Government's firm agenda to deliver greater levels of growth.

It is noted that the revised standard methodology for Surrey Heath requires a significant increase in housing delivery per annum from 320 dwellings to 658 dwellings, against an actual current delivery of 389 dwellings per year. This represents a proposed increase of approximately 106%.

Moreover, this represents a doubling to the starting point that Surrey Heath needs to address as part of its plan-making process. The current Regulation 19 Local Plan that is subject to consultation is based on a housing requirement of 5,578 dwellings over the plan period (at an average of 293 dwellings a year). This is significantly below the levels of growth anticipated by the revised standard methodology.

It is further noted that the Council is aware that there are a range of alternative sites that are both readily available and capable of delivering additional growth opportunities in the district. This includes Pine Ridge which as recently confirmed is available for development within the plan period. We challenge that assumption and note that the 'snapshot' in time the SLAA represents appears not to have been revisited.

Due to the above, the Pre-Submission Local Plan does not meet the "tests of soundness" as set out in the NPPF, namely it is not "positively prepared", "justified" nor is it "consistent with national policy". Given the above, we would strongly urge the Council to delay its Local Plan process, review the newly emerging standard housing methodology and to reconsider the site selection methodology.

We strongly urge the Council to not submit their Reg19 for examination and prepare a new Local Plan that is consistent with the 30th July Ministerial Statement and National Policy.

The draft NPPF sets out transitional arrangements at Annex 1, requiring Surrey Heath to not submit the current Reg19 and to create a new version that delivers significantly more housing. Based on the new standard methodology and having regard to the Council's existing spatial strategy, the Council needs to find additional land to deliver a further 4-6,000 homes over the same plan period. A very different spatial strategy is required for Surrey Heath, and an immediate need to identify more land for residential development.

The change requires re-assessment of all land in Surrey Heath, and therefore an updated SLAA. There are suitable, available and achievable potential developments sites, in keeping with the existing spatial strategy and sat in sustainable locations outside of the Green Belt that should now be re-considered and allocated for mix used development including housing. In particular, Pine Ridge which was assessed in the SLAA, at that time, as being a site that "could comprise an area for search for future development either within or beyond the plan period, should availability be confirmed". The site was discounted as an allocation due to the author's availability concerns. We note that the SLAA appears to have not been reconsidered as a living document, and that the Council has not sought to check details since it was first produced, raising concerns as to the accuracy of information feeding into the site selection process.

Any Council concerns around the availability of Pine Ridge are now resolved, evidence of which can been submitted to the Council to demonstrate delivery within the plan period. Within this context and the council's previous recognition of the development potential of this land the site should now be considered suitable for housing allocation.
