3. If any election is contested the poll will take place on Thursday, 7 May 2026.

5. Applications, amendments or cancellations of postal votes and amendments or cancellations of proxy votes must reach the Electoral Registration Officer at Surrey Heath House, Knoll Road, Camberley, Surrey, GU15 3HD by 5pm on Tuesday, 21 April 2026.
6. Applications for a Voter Authority Certificate or an Anonymous Elector's Document valid for this election must reach the Electoral Registration Officer by 5pm on Tuesday, 28 April 2026. Applications can be made online: <https://www.gov.uk/apply-for-photo-id-voter-authority-certificate>
7. New applications to vote by proxy at this election must reach the Electoral Registration Officer at Surrey Heath House, Knoll Road, Camberley, Surrey, GU15 3HD by 5pm on Tuesday, 28 April 2026.

Applications to vote by emergency proxy at this election must reach the Electoral Registration Officer at Surrey Heath House, Knoll Road, Camberley, Surrey, GU15 3HD by 5pm on Thursday, 7 May 2026. The physical incapacity must have occurred after 5 pm on Tuesday, 28th April 2026. To apply on the grounds of work/service, the person must have become aware that they cannot go to the polling station in person after 5pm on Tuesday, 28th April 2026.
