NOTICE is hereby given that in accordance with Regulation 24(2) and Regulation 36 of the Town and Country Planning (Local Development)(England) Regulations (as amended), Surrey Heath Borough Council formally adopted the Camberley Town Centre Area Action Plan Development Plan Document on 16th July 2014.

The Camberley Town Centre Area Action Plan contains policies to guide development within Camberley Town Centre. It complements the approach of the Council's Core Strategy which sets out the overarching spatial strategy and policies to guide development within the Borough until 2028.

The Camberley Town Centre Area Action Plan was subject to examination by an independent inspector in December 2013. The Inspector's Report was received on the 2nd May 2014 and can be viewed at the locations below.

Any person aggrieved by the adoption of the Camberley Town Centre Area Action Plan may make an application to the High Court under Section 113 of the Planning and Compulsory Purchase Act 2004 on the grounds that:

- The document is not within the appropriate power; and/or
- A procedural requirement has not been complied with

Any such application must be made no later than the end of the 6 week period from the date of adoption.
